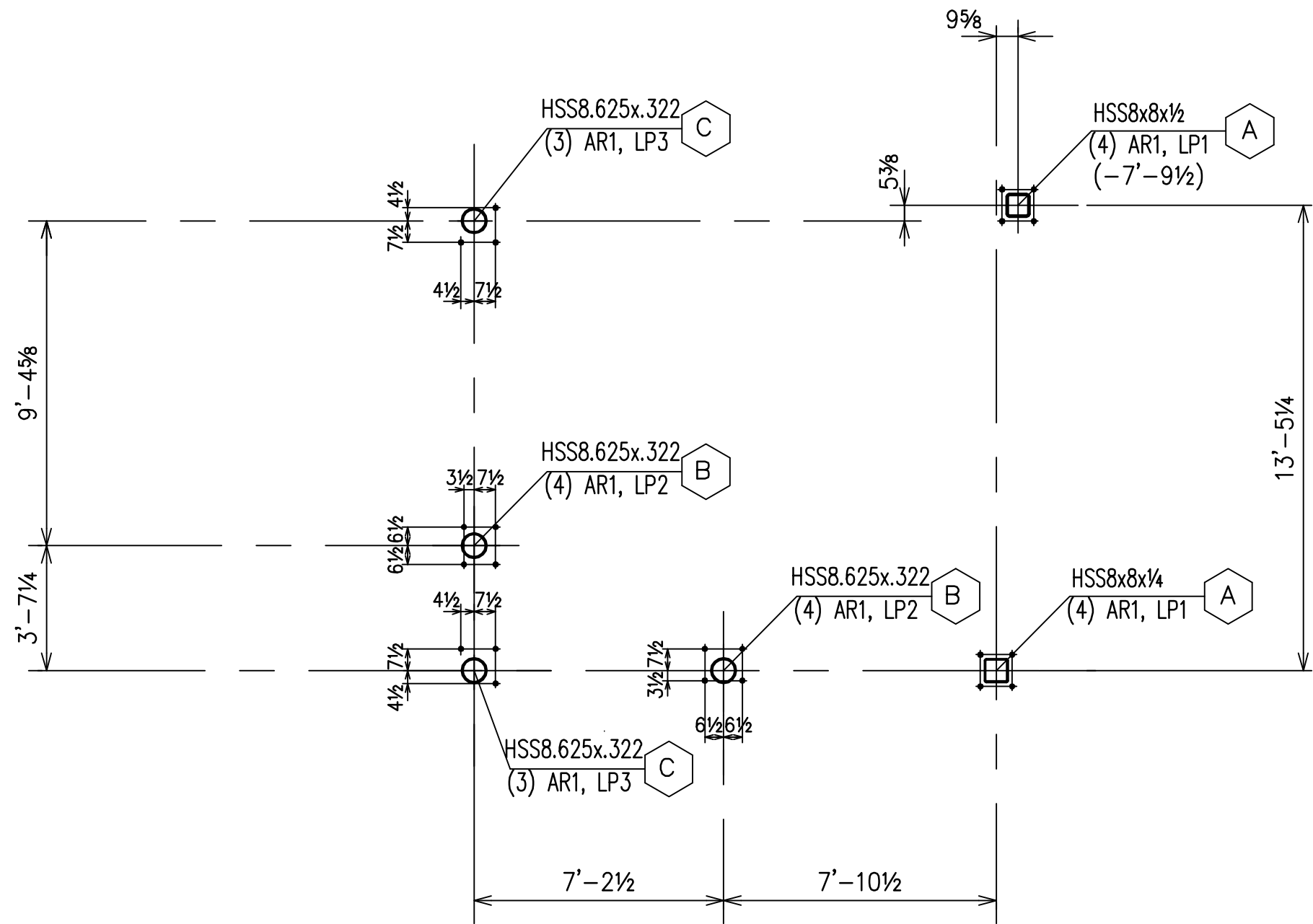




ANCHOR ROD SETTING PLAN
